General Conditions:

- All required tax returns must be filed.
- Interest and any applicable penalties will continue to accrue on the unpaid balance until paid in full.
- All future tax returns must be filed on time and paid in full.
- Any refund from taxes will be applied against the outstanding balance.
- Delinquency must be paid in full within the allotted time set by the agreement.
- To avoid the filing of a State Tax Lien, installment agreement must be completed within six months, or one year if an initial 25% down payment is made.
- If you fail to comply with these conditions, you will be in default on your agreement and we may take enforcement actions, such as file a State Tax Lien, Levy, Garnishment and/or refer to a private collection agency, for the entire amount you owe.
- If paying by check or money order, all installment payments must be made by the Payment Due Date. Check or money order must be in U.S. dollars payable to the **HAWAII STATE TAX COLLECTOR**.
- If paying by electronic funds withdrawal, the installment payments will be deducted from your bank account on the Settlement Date.
